Participants must follow the following rules during the Academy:

- Participants must be on time and stay for the entirety of the program
- Participants must be respectful at all times
- No put downs
- No use of profanity or swearing
- No weapons
- No violence or crime
- No use of tobacco of any kind
- No drugs
- No cell phones or electronic devices
- Students must participate in class
- Detective Griffith must be notified if a student is ill or unable to attend
- The Teen Academy shall not interfere with the routine operations of the WPD.
- Any participant who chooses to go against or not follow through with expectations of conduct will result in removal from the program.
