

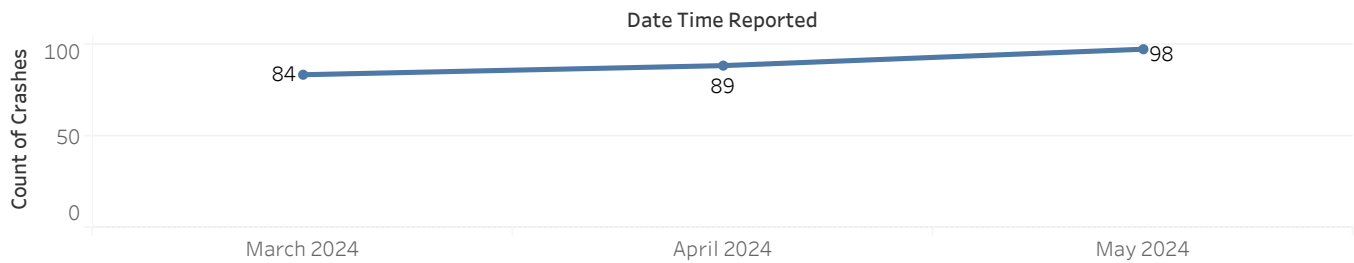

Crash Trend March to May

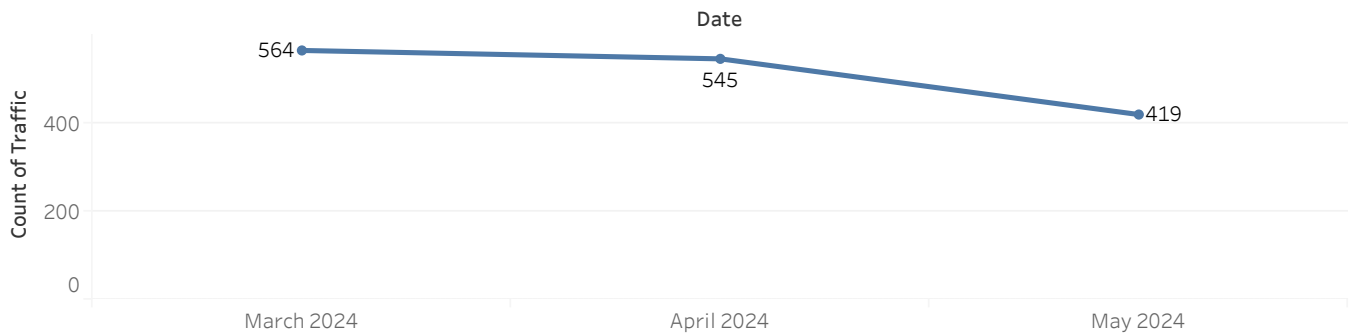


The trend of count of Crashes for Date Time Reported (MY). The view is filtered on Date Time Reported (MY), which has multiple members selected.

From March 1st to May 31st, WPD responded to an average of 90 accidents per month. This is a 7% increase from February to April's average.

Traffic enforcement efforts remain high but have slightly decreased, with WPD officers conducting 419 traffic stops for the month of May.

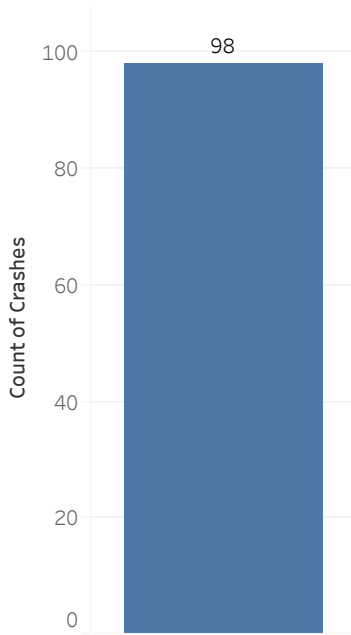

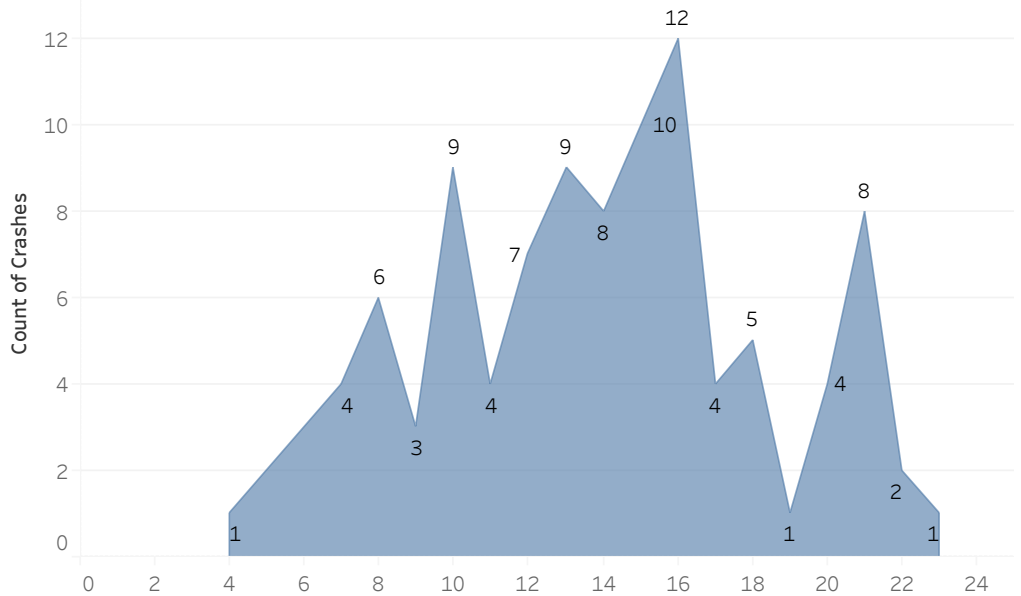

Crashes by Time

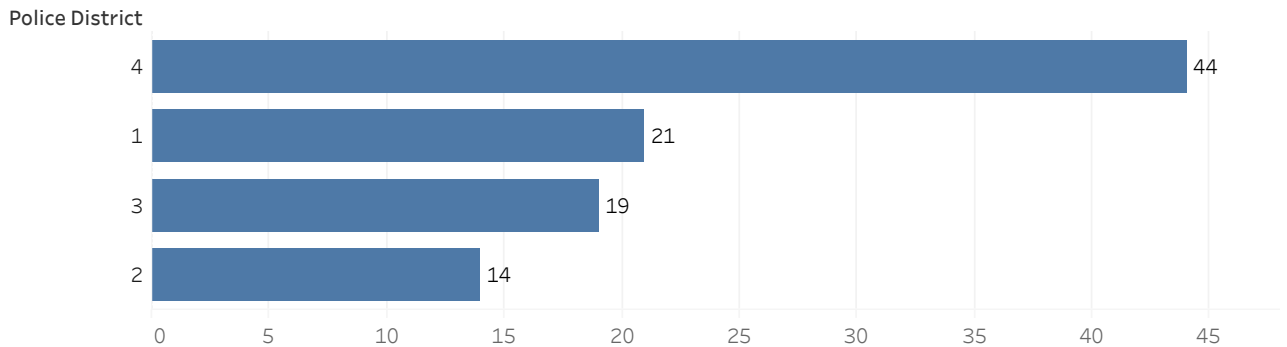


There were 98 total vehicle crashes in the month of May, with 62 Accident Reports completed. 36 accidents were non-reportable.

The highest crash hour in May remains 4pm.

Sector 4 had the highest number of crashes at 44 for the month, followed by Sector 1, then 3, and 2.

Crashes by Sector



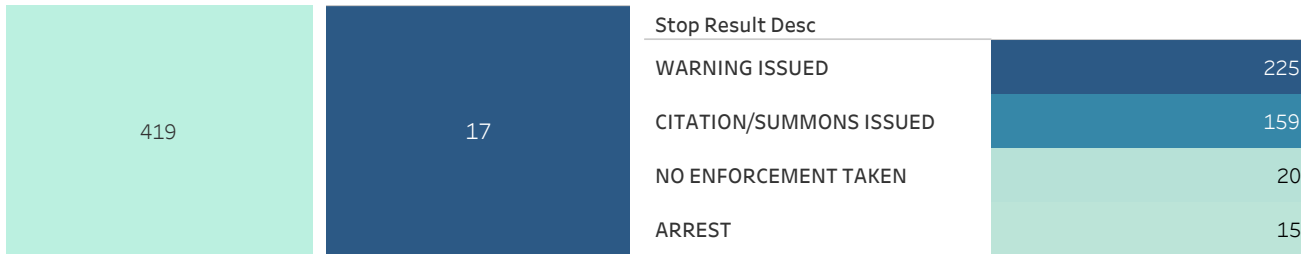

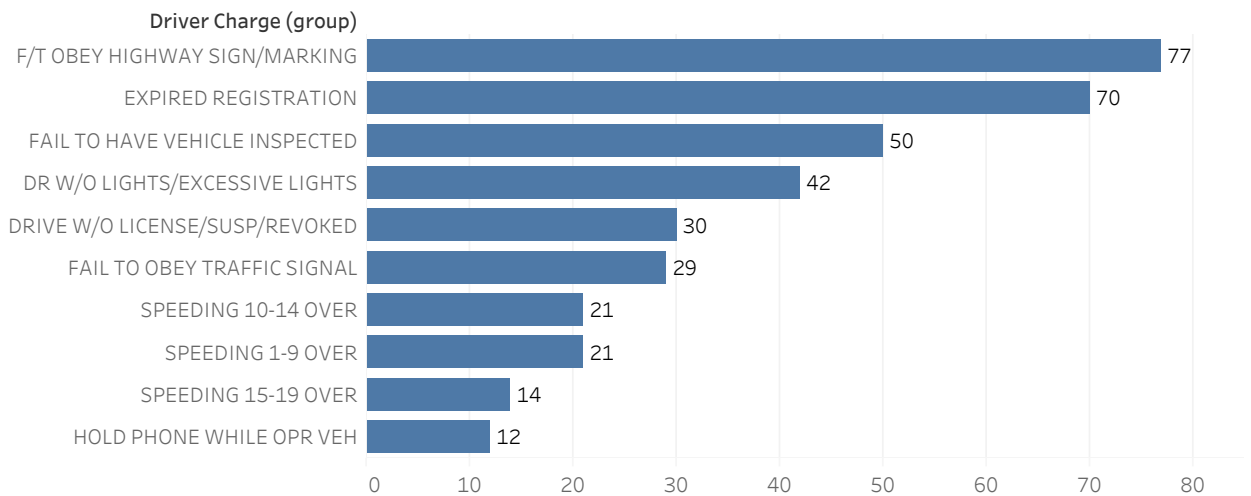


In the month of May, there were 419 total traffic stops, resulting in 159 Citations, 225 Warnings, 20 with No Enforcement, and 15 Arrests. There were also 17 DUI Arrests made.

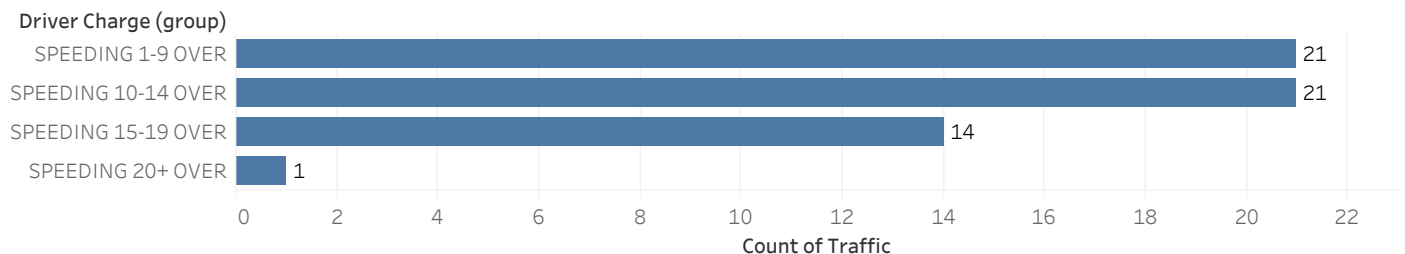
Note: DUI Arrests are not always a result of a Traffic Stop and are sometimes a result of a Traffic Crash.

The top reasons for Traffic Stops were Expired Registration, No Inspection, Failure to Obey Highway Sign/Marking, Driving without Lights/with Excessive Lights, and Driving without a License/Suspended/Revoked.

Top Reasons for Traffic Stops

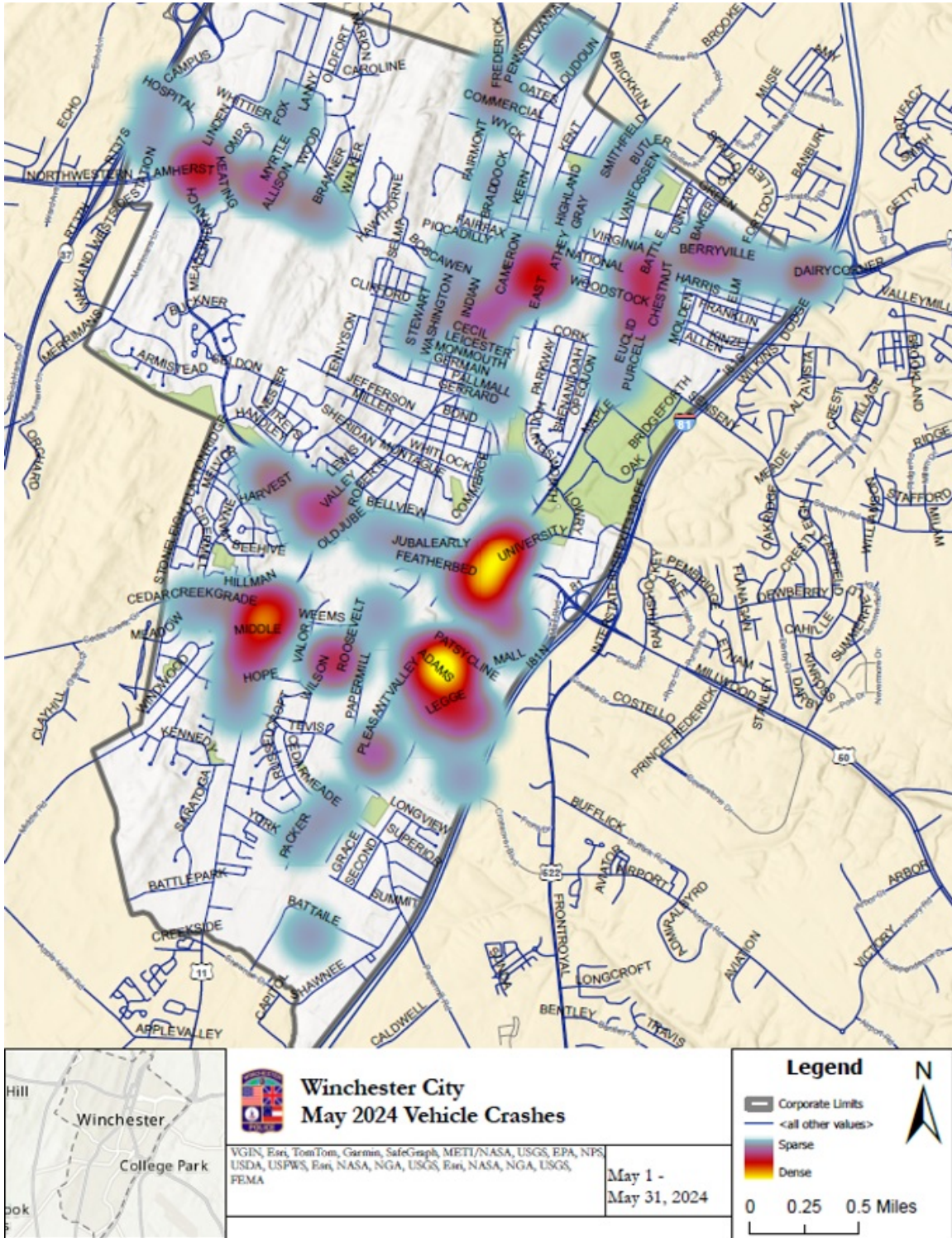

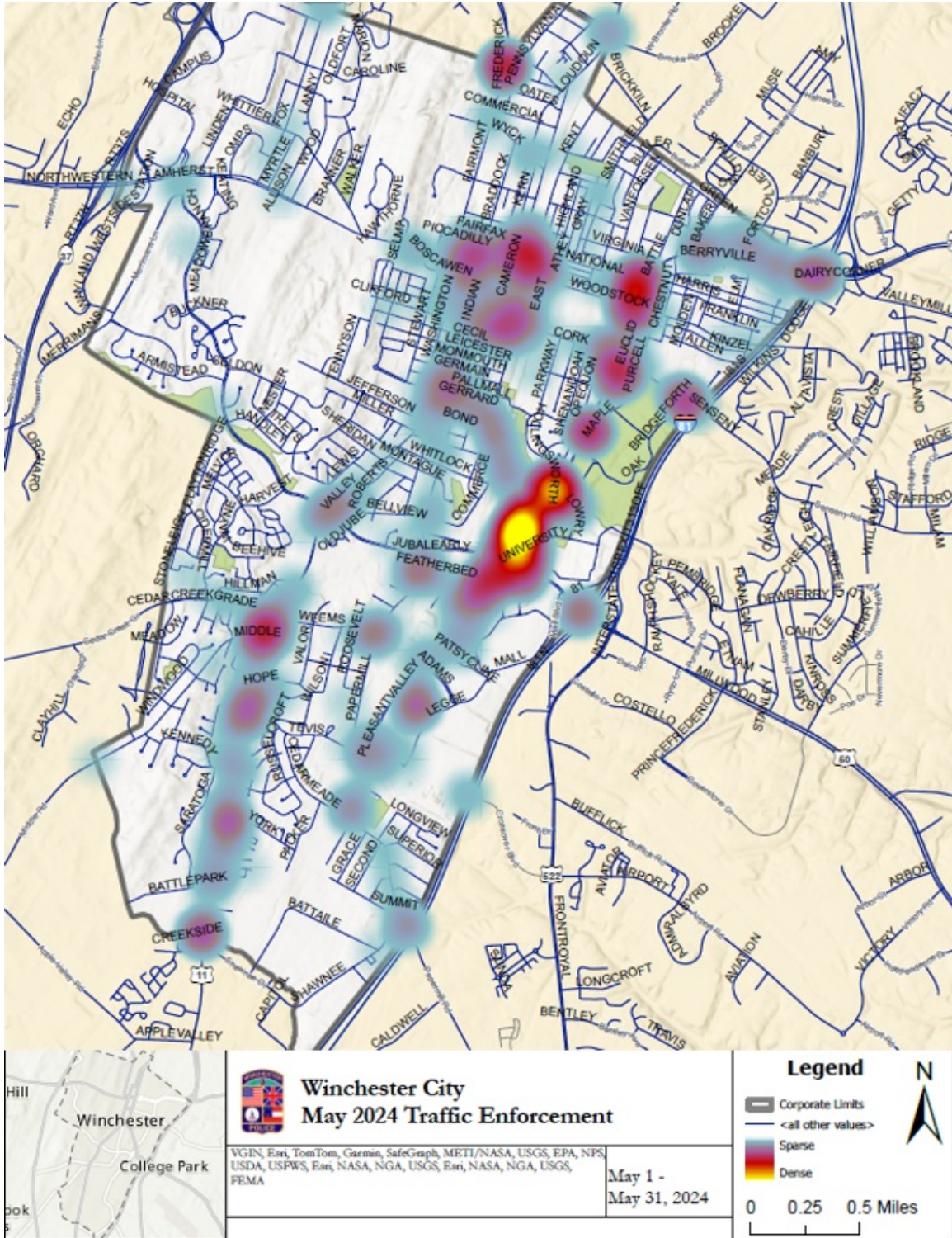

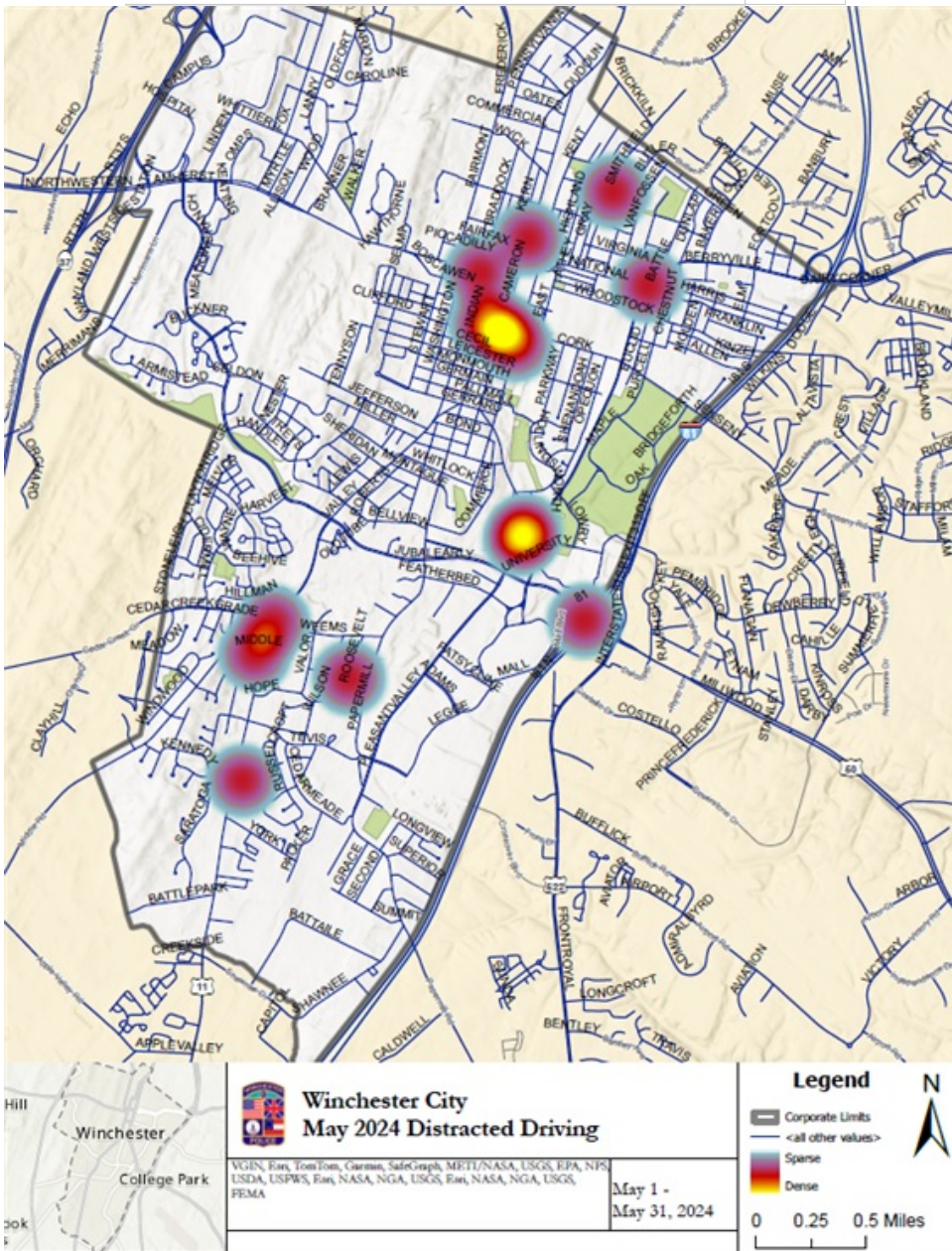

In May, there were 8 Citations and 6 Warnings written for distracted driving, making a total of 14.

4 were under the new City Code 14-35 and 10 were under the State Charge Section Code 46.2-818.2.
